Sub: Upgradation in respect of above said school.

With reference to your application dated 24.6.2009 and subsequent inspection of the school, I am directed to convey sanction for provisional affiliation to the above said school for Senior School Certificate Examination for a period of three years w.e.f. 1.4.2010 to 31.3.2013 in the following subjects:-

(a) Languages:-

English Core, Hindi Core and Malayalam

(b) Elective Subjects:-

Mathematics, Physics, Chemistry, Biology, Accountancy, Business Studies, Economics, Computer Science and Informatics Practices.

The sanction is subject to the fulfillment of the following conditions in addition to the general conditions intimated at the time of grant of provisional affiliation for secondary classes:

1. "The school will follow syllabi and courses as per scheme of studies prescribed by the Board for Senior School Certificate Examination and changes made therein from time to time."
2. The school will provide additional suitable facilities for classes XI and XII, as per requirements laid down in the rules.
3. It will increase the number of books in the Library and equipments in the Laboratories/Workshops with adequate games facilities etc. in consonance with the requirements of the Board for Classes XI & XII.
4. It will appoint only qualified staff to teach Classes XI & XII as per requirements laid down by the Board.
5. It will provide facilities for adequate co-curricular and extra-curricular activities for the wholesome development of the students.
6. It will abide itself by the Affiliation Bye Laws of the Board and other rules and regulations prescribed by the Board from time to time.
7. The school will enroll students proportionate to the facilities available in the school as prescribed in the Affiliation Bye-Laws of the Board which shall not in general exceed the optimum number as under from Pre-Primary to Class XII :-

8. School will provide physical facilities as per norms of the Board. The facilities reported at the time of last inspection are as given under:-

9. The school will strictly adhere with all rules regarding safety of students including Fire fighting, Drinking water, Sanitation, Transportation, etc.
10. Annual fee of Rs. 4500/- @ Rs.1500/- per annum for three years (01.04.2010 to 31.03.2013) be also remitted at an early date. (In case of overseas Independent school @ Rs. 5000/- p.a. and overseas Kendriya Vidyalayas @ Rs. 3500/- p.a.).
11. The school will apply for further Extension of Provisional Affiliation on the prescribed form together with the prescribed fee of Rs. 12,500/- and other essential documents in the preceding year before the expiry of the date.
12. The school will open CBSE pattern classes XI w.e.f. 1.4.2010. Accordingly, 1st Batch of class XII of the school will be appearing at the CBSE Examination to be held in 2012.
13. Other conditions are as per Annexure 'A' enclosed.
14. Special conditions to be complied within three months:-

- The School Managing Committee is required to be re-constituted by including representatives 02 each of Parents and Teachers of the concerned school.
- The school is required to appoint 03 more PRTs and 01 TGT to meet the section teacher ratio 1:1.5 teachers per section, as per present strength.
- The school is required to pay DA and other allowances on a similar rate to all the teachers instead of different rate to different teachers.
- The school has submitted the copy of EPF challans deposited for the month of Dec 2008, Jan 2009 and Feb 2009 and the above said 03 challan have been deposited on 18 June 2009. Therefore, the school is required to deposit amount of EPF subscription every month and photocopy of EPF challan of the latest month is also required to be submitted.
- The photocopy of the lease deed submitted by the school does identify its registration i.e. photocopy of the back page of the lease deed has not been made available by the school. Therefore, photocopy of the lease deed identified its registration may be submitted.
- The photocopy of the FDR maintained on account of Reserve Fund does not indicate the period nad date of maturity. Therefore, photocopy of the FDR maintained on account of Reserve Fund indicating the period and date of maturity may be submitted.
